Entry Deadline: Mon. November 3, 2008
Meet Starts: 10:00 am each day.

SANCTION: 08-213
Warm-up: Begins at 8:00 am

LOCATION: Palm Spring Swim Center. Take Interstate 10 East. Exit Highway 111. Turn left (east) on Ramon Rd. Turn left (north) on Sunrise to Baristo. Turn right (east) on Baristo to Pavilion Way (4 way stop sign). Turn right on Pavilion Way. Pool is located at the end of the street.

FACILITY: The Palm Springs Swim Center pool is an outdoor 50 METER pool with ten (10) all deep competition lanes, warm up/ warm down lanes available throughout the meet.

ELIGIBILITY: Open to 2008 and 2009 USA Swimming registered athletes who have achieved the entry time standards established for this meet. (See Special Entry Rules). Registration application must be received by SCS prior to the first day of the meet and may be submitted with entry. There are substantial penalties to swimmers and club (see the 2008 SCS Swim Guide), if USA Swimming registration is completed at the meet.

CHANGE OF AFFILIATION: Before the meet a swimmer may change affiliation by submitting a "Club Transfer" form and the appropriate fee to the SCS office. At the meet, a swimmer may UNATTACH by notifying the Administrative Referee in writing and paying the appropriate fee. A swimmer may not attach or reattach at the meet.

SUBMITTED TIMES: Submit Short Course Yard Times for each event, completing both sides of the **SCS BLUE** consolidated entry card. For electronic 'e-mail' team entries, see procedure on back page. If your qualification is by long course meters you must enter the minimum short course yard standard on the front of your entry card. **BONUS entries,- submit best recorded short course yard times and indicate (B) on the entry card for each bonus event entered.** Time standards must have been achieved on or after Sept. 1st, 2007 and must be verifiable. Meets outside SCS or non USA Swimming meets are provable only with official results subject to SCS approval. (Refer to the 2008 SCS Swim Guide.) You may swim a maximum of 4 individual events per day.

SPECIAL ENTRY RULES: **BONUS EVENTS.** A swimmer who has achieved one (1) or two (2) entry time standards may enter up to three (3) total events for the meet. A swimmer who has achieved three (3) or four (4) entry time standards may enter up to five (5) total events for the meet. Over five (5) must prove all events entered. The 1000, 1650, 400 Free and 400 IM may only be entered with achievement of the entry time standards.

ENTRIES DUE: Entries MUST be postmarked no later than midnight, Monday Nov. 3rd. Hand delivered entries received to the address below by 7:00pm, Nov. 5th will be accepted. NO LATE ENTRIES will be accepted. All entries not meeting the deadline WILL BE REJECTED.

ENTRY FEES: \$3.25 per individual event. \$6.00 surcharge per swimmer.
 \$8.00 per relay event. \$6.00 surcharge relay only swimmers.

DO NOT use certified or registered mail. Receipt of entry will not be confirmed by phone. Enclose a stamped, self-addressed post card or envelope with your entry for return of receipt. NO REFUNDS. RETURNED CHECKS will incur a service fee per SCS policy.

RULES: USA Swimming Rules will govern the conduct of this meet. Current SCS procedures shall be in effect and take precedence over any errors or omissions on this meet form. Swimmers must check-in with the Clerk of Course for each event. After an event is closed a swimmer may not check-in or scratch. This meet is TIMED FINALS.

MEET REFEREE/OFFICIALS: The Meet Referee is in charge of the conduct of the meet.

WARMUP: The competition pool will be available for warm-up at 8:00am each day of the competition. A Separate warm-up area will be available throughout the competition. SCS warm-up policy will be enforced.

TIMING: All competing teams will assist with timing and will be assigned timing lanes. Swimmers competing in the 1000 yd. and/or 1650 yd. freestyle must provide their own timer and lap counter.
